## E. ORDINANCES

- Consideration of Ordinance No. 4799 annexing a tract of land located generally north of U.S. 275 from Green Meadow Addition west to 250 feet west of 37<sup>th</sup> Street. This area includes portions of U.S. Highway 275 right-ofway and portions of 37<sup>th</sup> Street right-of-way. Ordinance No. 4799 passed on first reading at the May 16 City Council meeting and on 2<sup>nd</sup> reading at the June 6 City Council meeting.
- 2. Consideration of Ordinance No. 4803 changing the zoning from R-1 (Single Family Residential District) to C-3 (Service Commercial District) at 1001 Benjamin Avenue at the request of Dwain and Danielle Luhr and Beverlyann Brunswick. Ordinance No. 4803 passed on 1<sup>st</sup> reading at the June 6 City Council meeting.
- 3. Consideration of Ordinance No. 4808 creating a temporary parking prohibition on Maple Avenue from 18<sup>th</sup> Street west to the entrance to Skyview Park.
