- Consideration of Ordinance No. 4885 amending Section 22-40 of the City Code to require contractors who are eligible to do curb grinding under that section to be registered and to name the City as an additional insured on their insurance certificate; and amending Section 22-68 of the Code to provide for a charge per lineal foot of curb grinding done by the City. Ordinance No. 4885 passed on first reading at the May 15 City Council meeting, and on second reading at the June 5 City Council meeting.
